

PRIVACY POLICY

This Personal Data Privacy Policy (hereinafter – the “Privacy Policy”) is adopted in accordance with the requirements of the Law of the Republic of Belarus No. 99-3 dated May 7, 2021, “On the Protection of Personal Data,” and applies to all information that Individual Entrepreneur Roman Cheverda may obtain about Users while using the website <https://openevisa.com>.

1. General Provisions

1.1. This Privacy Policy describes the methods of collection, use, and storage of personal information by Individual Entrepreneur Roman Cheverda of clients visiting the Website (hereinafter – the “Site”).

1.2. By using the Site and providing personal information through it, the Client consents to this Privacy Policy, the processing of their personal data, and the transfer, use, and disclosure of such personal data in accordance with this Privacy Policy.

1.3. If the Client does not agree with the terms of this Privacy Policy, they must stop using the Site.

1.4. This Privacy Policy applies exclusively to personal information obtained through the Site. Personal information is information that allows the identification of the Client, either individually or in combination with other available information.

1.5. This Privacy Policy applies only to the Site. The Site does not intentionally publish links to external Internet resources that may damage the Client’s computer or infect it with viruses.

1.6. The Site administration does not verify the accuracy of personal data provided by the User.

1.7. Viewing content on the Site is anonymous. Site servers may collect statistical information about browser type, computer, operating system, and IP address.

1.8. Data collected and stored include personal data, as well as any other information permitted for processing under this Privacy Policy, which Clients consciously and voluntarily provide by filling out registration forms or performing other actions on the Site, including:

- Full name;
- Email address;
- Contact phone number;
- Selected services.

1.9. Information is collected for the purpose of:

- Accepting, processing, and delivering orders;
- Providing feedback and communication with the Client;
- Providing Client support, including sending notifications and inquiries regarding Site usage.

2. Confidentiality and Data Sharing

2.1. Individual Entrepreneur Roman Cheverda never discloses personal information of Clients to third parties, except as required by the Law of the Republic of Belarus No. 99-3, or when the Client voluntarily consents to such disclosure.

2.2. Individual Entrepreneur Roman Cheverda may engage other companies or individuals to perform specific tasks, such as:

- Email and postal delivery;
- Removal of duplicate data from client lists;
- Data analysis;
- Provision of marketing services;

- Credit card payment processing.

These entities may access personal data **only to perform their designated functions** and may not use it for other purposes.

2.3. Personal data may be disclosed to authorized governmental authorities of the Republic of Belarus only on grounds and in the manner established by law.

3. Data Protection Measures

3.1. Individual Entrepreneur Roman Cheverda implements measures to protect Clients' personal data, including:

- Preventing leaks of personal data through technical channels and other means;
- Preventing unauthorized access to personal data or attempts to obtain, destroy, alter, or block access to such data;
- Protection against malicious software;
- Detection of intrusions and computer attacks.

4. Data Retention

4.1. Personal data is retained only for as long as necessary to achieve the purposes for which it was collected, or for other legitimate purposes, except where a longer retention period is required or permitted by law.

4.2. Clients may withdraw consent to the storage and processing of personal data by submitting a request for deletion to: openevisa@gmail.com.

5. Payment Security

5.1. All credit card transactions are processed securely by banks using protected modes.

6. Policy Duration and Updates

6.1. This Privacy Policy is effective indefinitely until replaced by a new version.

6.2. Changes to the Policy will be reflected in this document. Individual Entrepreneur Roman Cheverda reserves the right to amend any sections of this document at any time without prior notice by publishing an updated version on the Site. Users are bound by the new terms from the moment of publication.
